

## **Letters to the Editor of the Kensington Outlook, MAY 2008**

Dear Kensington Outlook Editor,

Bruce Morrow, the president of the Kensington Community Council (KCC), has taken offense at an article in the April issue of the Outlook that was interpreted by him as unflattering toward the Kensington Police Protection and Community Services District (KPPCSD). As a result, at the April 7, 2008, meeting of the KCC, Mr. Morrow demanded that all future articles be screened and approved by him. At that point, John Feld chose to resign as editor rather than compromise his editorial and journalistic integrity. While the KCC may consider the Outlook to be a “newsletter” rather than a “newspaper”, Kensington residents have come to view the Outlook as their primary independent source of local news where they can read about decisions and actions of the KPPCSD Board or any other group that affects their quality of life. Imposing censorship or insisting that only “feel good” articles be published goes against the fundamental principles of a democratic society and is definitely not in the best interests of the community.

There are two questions that I feel need to be answered:

1. Do the opinions and actions of Mr. Morrow reflect a consensus of the KCC Board members or was this action taken unilaterally. While I disagree strongly with the action, I think it is important that the public know if it was supported by the board as a whole or was this decision made solely by Mr. Morrow.
2. Of more fundamental importance, was Mr. Morrow encouraged to apply pressure to Mr. Feld by members of the KPPCSD Board of Directors? KPPCSD Directors are elected representatives of the community and any interference by them in the evaluation, selection or editing of individual articles, either directly or by creating an environment in which editorial decisions are strongly influenced would be an abomination. To date, only one KPPCSD Board member, President Cindy Kimball, has issued a public statement on the issue of John Feld’s resignation. She supports John’s position to be able to edit the Outlook without prior review or consent from the KCC. No other KPPCSD Board member has publically expressed an opinion on the matter and I encourage them to do so. We have a right to know how our elected officials stand on this issue.

To The KCC, Kensington government and community -

There is a great need for people to know fully what the Boards and other Kensington policy bodies talk about, for simple transparency of government. At the present time not enough people run. When a term of office is up, the person just stays on. Without full coverage of meetings Kensington citizens are functionally illiterate about how our town is run: don't understand or follow the issues closely and are disinclined to bring their skills to community positions.

John Feld was scrupulous about not confusing opinion and news coverage; he knew his employers' caveats and worked within them. He hosted valuable breakfasts; made it his business to understand how Kensington worked; went to every meeting. He was hired to put out a lively, full-coverage paper. He has been reprimanded rudely; the future of the newspaper and open communication in Kensington has been thrown into turmoil by the seeming disrespect of one person towards the Editor. And yet I am sure there are two sides to this story, and I wasn't a party to the actual argument. Perhaps a first step might be an apology and a willingness to make the boundaries clear of appropriate oversight.

A planning meeting should be held of people who support the kind of newspaper John knew enough how to run. An Editorial page with Letters to the Editor on significant subjects should be added. By-laws and mission statement need to be updated. It perhaps should have its own Board of people who have background in non-profit management, journalism and publishing, so it is not overly tied to one Council who may try to control it. It may have once been the mouthpiece of the KCC, but its present function is the only means of communication these councils and boards have with the community and has long since left behind its "newsletter" days.

In Berkeley the minutes of each commission appear on the city website, with no discussion. The Daily Planet helps the citizens know more. Such a paper assumes an open press, and ours should too. Requiring an editor to submit all copy before publication is censorship, and breaks several federal laws in this country relative to freedom of the press.

Kensington Outlook

I was saddened and deeply troubled by the actions of the KCC and its president Bruce Morrow in imposing editorial restrictions on John Feld, the former editor of the Outlook and on his reporting of local news to our community. Both the KCC and Mr. Morrow were effectively requiring that Mr. Feld report the news that they saw fit to publish, rather than give Mr. Feld the necessary editorial independence to report the facts as they occurred. Under these circumstances, Mr. Feld did the only thing he could do, which was to resign as editor. The conduct of both Mr. Morrow and his board here is utterly offensive and has no place in our community.

Mr. Morrow apparently justifies his actions in part based on his belief that the KCC, as a nonprofit publisher of the Outlook cannot take part in partisan politics in fear of jeopardizing its federal tax-exempt status. Based on my review of these series of articles, Mr. Feld was not engaging in prohibited political activities, but was instead reporting newsworthy events to a concerned citizenry. His journalism shone a bright light into the many dark crevices of our local governing bodies. While such actions may result in news that is unflattering to certain individuals and public bodies, they serve the larger and vital purpose of informing all of our opinions on public matters.

Mr. Morrow is attempting to mold the news into what he and his constituencies feel it should be, rather than allow unfettered factual reporting and let the political chips fall where they may. Such action is wholly inappropriate anywhere in this country and constitutes an unconscionable prior restraint that indelibly stains our First Amendment.

Editor:

I understand that John Feld, the former editor of *The Outlook*, resigned as editor as a result of (1) his refusal to allow the KCC president to review and pre-approve all articles to be published in *The Outlook*, and (2) objections raised by the KCC president in response to his publication of an article that could be read as mildly critical of the KPPCSD Board.

These are strange times, indeed. Kensington prides itself, or so I thought, on being an open community. A free press is generally considered to be one of the pillars on which an open community rests. Even had the article been extremely critical of the KPPCSD Board, it should not have led to Mr. Feld's resignation.

While KCC may view *The Outlook* as a "newsletter" as opposed to a "newspaper," a distinction wholly lost on many of us, the community by and large views it as an important source of information, and one that should be free from political pressure directly or indirectly brought by elected officials in our community. The hiring and firing (or pressuring) of editors based solely on their published views of the actions taken by those same elected officials is, simply put, wrong. It would also seem to be unconstitutional—at least in spirit.

The KCC Board, quite frankly, need to rethink its position vis-à-vis *The Outlook*. The members of the KCC Board are supposed to be thinking of the community they serve. The KPPCSD Board members are elected officials who chose to run and to serve. They should, like all elected officials, be held accountable for decisions they make. *The Outlook* had been one of the very few vehicles for providing this sort of accountability. No longer.

I'm betting that J. As an unincorporated community, with no right to enact an ordinance of its own, Kensington has been cleverly targeted by T-Mobile as a dandy site for cell phone towers - - better than those pesky adjoining (and incorporated) communities like El Cerrito, Albany and Berkeley, who have passed ordinances limiting placement of such towers in residential areas. Upwards of 60 homes (one of them mine) in El Cerrito will receive exposure from the tower, and at least as many in Kensington.

I'm hoping that the spirit of Oppenheimer, along with our neighborhood's testimony, will inspire KMAC to make their advice to the county be a clear "NO cell tower in Colusa Circle. Kensington concurs with her neighboring communities. Cell phone towers don't make good neighbors."

Editor –

KMAC reviewed a permit for a cell tower at 367 Colusa. It will emit RF radiation to everyone within 1500 feet. Ordinances were passed in El Cerrito, Richmond preventing installations within 300 feet of homes, yet this was ignored by TMobile when they approached the building's owner.

Health issues related to cell tower radiation exposure are in dispute, a situation felt by many to be due to the fact that research is often funded by the cellular industry. Nevertheless, there is mounting evidence it is a danger to children who are the most vulnerable, with higher incidences of blood disorders/leukemia and other disorders in adults as well. U.S. firemen will not permit towers on their facilities until there is proof of no danger. The tower would be 230 feet from a nursery school, 300-400 ft from Semifreddie's, The Pub, and offices. While the federal government has guidelines regarding the safe amount of exposure, there is controversy within the scientific community if the guidelines are too lax. Frankly, basing guidelines on behavioral changes in rats would call them into question. Simple prudence would dictate caution in the placement of these radiation sources.

Since 1992, appraisers' and urban planners' research find home values near towers and power lines decrease 2-20% or more, due to perceived dangers.

This means lost value to owners and lost county taxes. There are about 800 homes within 1500 feet, 65 homes and commercial property within 300 feet .

Is it worth it to risk being exposed? RF's cumulative effects on the body are unknown. Many people will avoid the Circle, if it's installed. Do we want to see our property devalued?

Mr. Caruso needs to do the right thing and break his contract with TMobile.

I write as a former member of the KCC board (1989-1994) appalled by the recent action of the current KCC President to exert his personal position over the editorial content of the Outlook.

During my board term, two attorney members of the KCC board, John Vlahos and Barrie Engel, advised that KCC board NOT to interfere with journalistic freedom. During those days, the community was involved in campaigns both to purchase surplus property from the WCCUSD to create a park as well as to pass an assessment to fund the police department. The Outlook editor at the time, Diane Gossard, attended all the various K-group meetings and reported in each issue of the Outlook summaries of the conversations and decisions made by those groups. Both measures passed and today Kensingtonians have a beautiful park and a fully staffed police force.

In reading the recent issue of the Outlook I appreciated the editor's articles about the current KPPCSD budget shortfall and the possibility being discussed by concerned citizens that assessments to fund Park improvements and the police department may be needed. Had I not read this issue of the Outlook I would have been unaware of the current fiscal situation.

I hope the KCC board will reconsider its actions and attempts to silence editorial opinion. The Outlook has grown to be more than a newsletter of the KCC and serves an important journalistic purpose to keep Kensington residents informed and involved in matters that impact our town.
